1. I agree to provide access or keys to be available for Stephanie King of All About Dogs for the dog walking appointment.
2. I accept that while my dog(s) is in day-care, all efforts will be made to walk all day-care dogs it is not guaranteed this may not be possible due to arrival/departure time as well as time commitments to other dogs.
3. Dogs that are boarding withal About Dogs need to be collected before 12 noon on the day of their departure or day-care charges will be applied.
4. I authorise All About Dogs to obtain any emergency veterinary care that may be necessary during the time spent with my dog(s). I understand that every effort will be made to contact me prior to obtaining emergency care. I accept responsibility for any charges related to this emergency care. I authorise All About Dogs to use an alternative veterinarian if my regular veterinarian is unavailable.
5. I agree to reimburse All About Dogs for any additional fees providing emergency care, as well as any expenses incurred for unexpected visits, transportation, housing, food or supplies.
6. I will be responsible for any medical expenses and damages resulting from an injury to the dog walker or other person by my dog(s). I agree to indemnify and hold harmless All About Dogs in the event of a claim by any person injured by my dog(s).

7. If my dog is female, I will notify All About dogs when my dog is in season. During these times I understand that my dog will be walked alone for safety purposes and that will incur the single dog walking fee.
8. I agree to notify All About Dogs of any concerns/complaints within 24 hours of any appointment.
9. I realise I must give a minimum of 24 hours' notice to cancel any appointments or the full amount for the walk will be payable.
10. I will settle the amount owing at the end of each week/month in which walks have been undertaken.
11. Where dog walking is a regular arrangement over a period of time with no defined end, I and Stephanie King both agree to a two week notice of termination of the agreement.
